

SASF AA Conference

The annual SASF AA (Southern Association of Student Financial Aid Administrators) conference was held this year in Biloxi, Mississippi, from Feb. 13–16. SASF AA is a regional association with representatives from Virginia, North Carolina, South Carolina, Georgia, Florida, Alabama, Mississippi, Tennessee, and Kentucky. The conference was located in the Biloxi Grand Casino, but everyone concentrated strictly on the seminars that were available. Those who were flying into the local airport did have some interesting stories of their flights because of the severe storms that occurred on Sunday, but everyone was happy to arrive safely.

Representatives from the Department of Education presented many of the sessions and the information was extremely helpful as well as providing contacts with the Department. Our own Linda Phillips from Belhaven College was a presenter for the FFELP (Federal Family Education Loan Programs) Master Promissory Note: Tales from Those Who Have Been There.

Two sessions addressed Internet access to the IFAP (Information for Financial Aid Professionals) and NSLDS (National Student Loan Data System). These Web sites are becoming valuable informational tools. Both sites are constantly trying to provide the information that financial aid professionals need to make their jobs easier and to help with all of those regulations. February Teleconference

We began our teleconference with a brief discussion of the SASFAA conference generally, and cohort default rates in particular. The cohort default rate discussion was timely because the draft cohort default rate materials were mailed to institutions on February 15, 2000. None of the teleconference participants intended to challenge the cohort default rates at their institutions since their default rates were low.

Next, we discussed the new consumerism requirements. Most participants acknowledged that they were either in the process of updating their consumerism information or that they had not begun the updating process. Participants were encouraged to begin drafting the updates to their consumerism information as soon as possible to avoid noncompliance. Participants were also encouraged to work with other departments at their institutions to ensure that all of the consumerism requirements are met. Adrienne Jones stated that she has written a position paper on consumerism that will be posted on the IPD Financial Aid Global Distribution List in the coming weeks.

Adrienne Jones reminded the teleconference participants that the Spring IPD Financial Aid Training session would be conducted on March 15–16, 2000. Approximately 20 people are scheduled to attend the session.

Kristen Vedder announced that plans for the IPD Financial Aid Annual Conference are well underway. The conference is scheduled for June 15–16, 2000. This year's conference will be a joint conference between IPD Financial Aid and CAAHE (Consortium for the Advancement of Adult Higher Education). We also discussed this year's inclusion of Department of Education presenters at the conference also. Participants were enthusiastic about the opportunity to hear from the Department of Education directly. Teleconference participants were advised to ask questions freely of the Department of Education presenters, without fear of program reviews, since the Department does not penalize questioners for attempting to comply with the regulations.

The topic of state grant funds for nontraditional students also arose during the teleconference. Participants indicated that they were having difficulty securing state grant funds for their nontraditional students. Adrienne Jones offered to assist institutions with obtaining those funds.
